NPOP Accreditation by NAB

INDOCERT is accredited by National Accreditation Board (NAB) as per National Programmed for Organic Production(NPOP). NPOP is a programme under Government of India which involves the accreditation of certification bodies, standards for organic production, promotion of organic farming and marketing etc.

INTERNATIONAL ACCREDITATIONS



IOAS

INDOCERT is internationally accredited by IOAS and is compliant with ISO/IEC 17065:2012, to carry out certification of products, processes and services in organic production for the categories of unprocessed plant products, agricultural products for the use as food and agricultural products for use as feed based on INDOCERT Organic standard for Non EU country operators (equivalent to Reg EC. No 834/2007 & EC No. 889/2008).

EU Equivalence Programme

INDOCERT is recognized as an equivalent certification body (listed by European Union in the list of inspection and certification bodies recognized from EU) IOAS accredited INDOCERT as per ISO17065 to carry out certification of products according to INDOCERT Organic Standard (equivalent to EC Reg. No.834/2007 and 889/2008) for Non EU country operators.



Great Britain (GB) equivalence programme

INDOCERT is recognized by the Department for Environment, Food, and Rural Affairs (DEFRA) in the United Kingdom to certify organic products according to INDOCERT Organic Standards for export to Great Britain. These standards are equivalent to EC Regulation (EC) No 834 / 2007, Regulation (EC) No 889 / 2008, and Regulation (EC) No 1235 / 2008.

Swiss Equivalent Control Body

INDOCERT is also included in the Swiss list of Control Bodies that can provide equivalent guarantees for products produced in accordance with Swiss Ordinance of Organic Farming. This equivalent guarantee is for products certified as per INDOCERT Organic Standards for Non EU Country Operators.



COR (Canada Organic Regime) by CFIA

INDOCERT is accredited by the Canadian Food Inspection Agency (CFIA) on the recommendation of IOAS to certify agricultural products, packaging and labeling activities as organic in accordance with the requirements set out in Division 4, Part 13 of the Safe Foods for Canadians Regulations and the requirements outlined in the Canada Organic Regime Operating Manual. Now INDOCERT is accredited to operate in countries Sri Lanka, Ecuador, Vietnam and Uganda besides India.



Rainforest Alliance (RA)

INDOCERT is authorized by Rainforest Alliance to conduct certification activities for the 2020 Rainforest Alliance certification programme. The authorization is based on the 2020 Rainforest Alliance Sustainable Agriculture Standard for Farm and Supply Chain clients.

OUR SERVICES



NPOP

INDOCERT offers organic certification services based on National Standards for Organic Production (NSOP). INDOCERT certification scopes under NPOP covers Crop Production, Food Processing and Handling, Animal Feed Processing and Trading and Mushroom.



EU Equivalent Certification

INDOCERT offers EU Equivalent certification based on INDOCERT Organic Standard for non EU country operators (Reg EC. No 834/2007 & EC No. 889/2008). The scope of certification service includes unprocessed plant products (Category A) , processed agricultural products for the use as food (Category D) and processed feed products (Category E).



Great Britain (GB) Equivalent Certification

INDOCERT offers certifications by using the INDOCERT organic standards for export to Great Britain and agricultural products that comply with these standards can be placed on the GB market. The scope of certification service include Unprocessed plant products (Category A), Processed agricultural products for use as food (Category D), and Processed agricultural products to use as feed (Category E).



COR (Canada Organic Regime)

The Canada Organic Regime (COR) is the federal regulatory program for Canadian organic products. INDOCERT's scope for COR certification covers crop production, specialized production –wild crops, livestock feed and processed agricultural products. INDOCERT also offers COR certification under US-Canada Equivalence Arrangement (USCOEA).



USDA-NOP

INDOCERT offers USDA NOP certification in collaboration with bio-inspecta Switzerland. The scope of certification includes Crop Production, Grower group, Handling(Processing/Trade) and Wild Collection.



Bio Suisse

INDOCERT is qualified by International Certification BIOSUISSE AG to carry out Biosuisse inspections for Processed Agriculture Products for the use as food.



Naturland

Naturland certification guarantees to consumers that products meet the strict ecological and social requirements of Naturland standards. Naturland producers all over the world practice organic farming. INDOCERT provides inspection services as mandated by Naturland for producers and processors according to Naturland standards.

Input Approval

INDOCERT evaluates inputs used in organic production and confirms their compliance with the NSOP. INDOCERT provides organic input approval certification for fertilizers, plant conditioners, soil conditioners, pest and disease control products.



The Organic Material Review Institute Listed® seal assures the suitability of products conditionally approved for use in certified organic production, handling, and processing. INDOCERT is the OMRI approved inspection body for the purposes of inspecting and evaluating organic inputs for a input manufacturers.



Rainforest Alliance is an alliance of farmers, forest communities, companies and consumers to protect forests, improve the livelihoods of farmers and forest communities, promote their human rights, and help them mitigate and adapt to the climate crisis. INDOCERT offers Rainforest Alliance certification for Single farms, Multi farms, group of farms and supply chain entities for Single site and Multi site as per following standards:

- Rainforest Alliance Sustainable Agriculture Standard Farm requirements
- Rainforest Alliance Sustainable Agriculture Standard Supply Chain requirements



UEBT is a non-profit membership organisation working with the ethical sourcing of ingredients from biodiversity. UEBT certifies organizations and their suppliers sourcing specialty ingredients for the beauty, food, natural pharmaceuticals, flavours & fragrances, herbs and spices. UEBT has qualified INDOCERT for conducting third party assessments in its ethical sourcing system and natural ingredient certification programs(UEBT) and in UEBT/Rainforest Alliance scopes.



INDOCERT offers trustea certification for Indian tea estates, factories, smallholders group and Bought Leaf Factories (BLFs) as per the trustea Code. trustea is an Indian sustainability code and verification system which addresses the social, economic, agronomic and environmental performance of the tea sector.



4C certification applies high standards on economic, social and environmental conditions for coffee production and processing to establish sustainable, trustworthy and fair coffee supply chains. INDOCERT is approved by 4C Services GmbH, Germany to offer 4C certification services in production and chain of custody.
